The Project Priority Listing Vote has closed, and has unanimously passed with Coalition/CoC approval. The following list of projects (included in the attachment in table form) will move forward to the U.S. Department of Housing and Urban Development as our proposed projects and funding levels.

This email summarizes the list of projects that have been proposed by the Coalition (CoC) Project Funding Evaluation Team (PFET) to be included in the York City/County CoC Project Priority Listing for funding. This includes renewal projects and new projects that will be submitted.

Please note that the CoC did not reallocate funding from any renewal projects for the FY 2023 CoC NOFO Competition, and did not receive any voluntary reallocation requests.

Please note that the CoC did not reduce funding from any renewal projects for the FY2023 CoC NOFO Competition.

The CoC did reduce one (1) new project budget amount, due to insufficient funding available in the FY 2023 competition to award funding in the full amount requested by the new project applicant.

Please also note that the CoC did not reject any new project applications during the FY2023 CoC NOFO.

RENEWAL PROJECTS

The following renewal projects have been recommended by the Coalition (CoC) PFET and to be included in the Project Priority Listing submitted to HUD. Each of these projects is recommended for funding at the amount listed below. **All projects were awarded their full Annual Renewal Demand (ARD) demand, based on the 2023 Grant Inventory Worksheet (GIW).**

As identified on the attached Project Priority Listing, PA0972 – York CoC Medium Term RRH & PA0676 – Continuum of Care RRH Rental Assistance (both held by the grantee, County of York) are requesting consolidation during the FY2023 NOFO. NEW PROJECTS

The Coalition (CoC) received three (3) new project applications totaling \$400,905 in funding. The Coalition (CoC) has a total of \$479,188 in funding to award. This amount includes funding from the following sources: the CoC Bonus (\$197,313) and the DV Bonus (\$281,875). As a reminder, the CoC did not elect to reallocate funds from renewals for FY2023, and the CoC received no voluntary reallocations.

One (1) new project application met the criteria for the DV Bonus.

All three (3) new projects were accepted for funding; one project had a reduction in funding amount due to amount of available funds under the CoC Bonus.

The following new projects have been accepted for inclusion on the Project Priority Listing for funding. **Please note one new project accepted had a budget reduction from their original proposal.** Listed in alphabetical order:

· County of York – York County Homeless Management Information System (HMIS) - **Expansion**

- **Approved for the full amount requested (\$80,000) under the CoC Bonus**

· Turning Point Interfaith Mission – PH for PWD - **Expansion**

- **Requested \$164,901 in funding. Due to limited funding under the CoC Bonus, this project was reduced to \$117,313. Project confirmed approval of the lower funding amount to move forward.**

· County of York – RRH for DV Households - \$156,004

- **Approved for the full amount requested (156,004) under the DV Bonus**

REDUCED PROJECTS

The Coalition (CoC) had to reduce one (1) project application received. This project was a new project, and was reduced due to lack of sufficient funds in the FY2023 CoC competition to fund their full amount requested.
